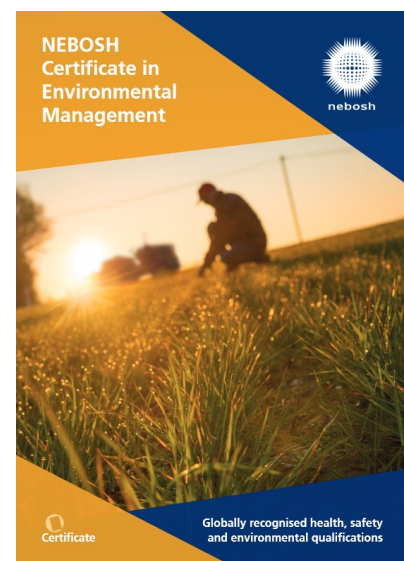
Course details
